Solution

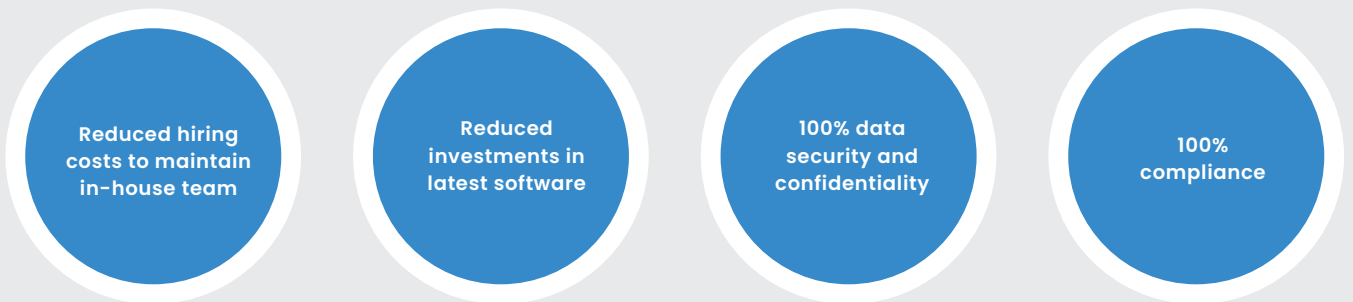
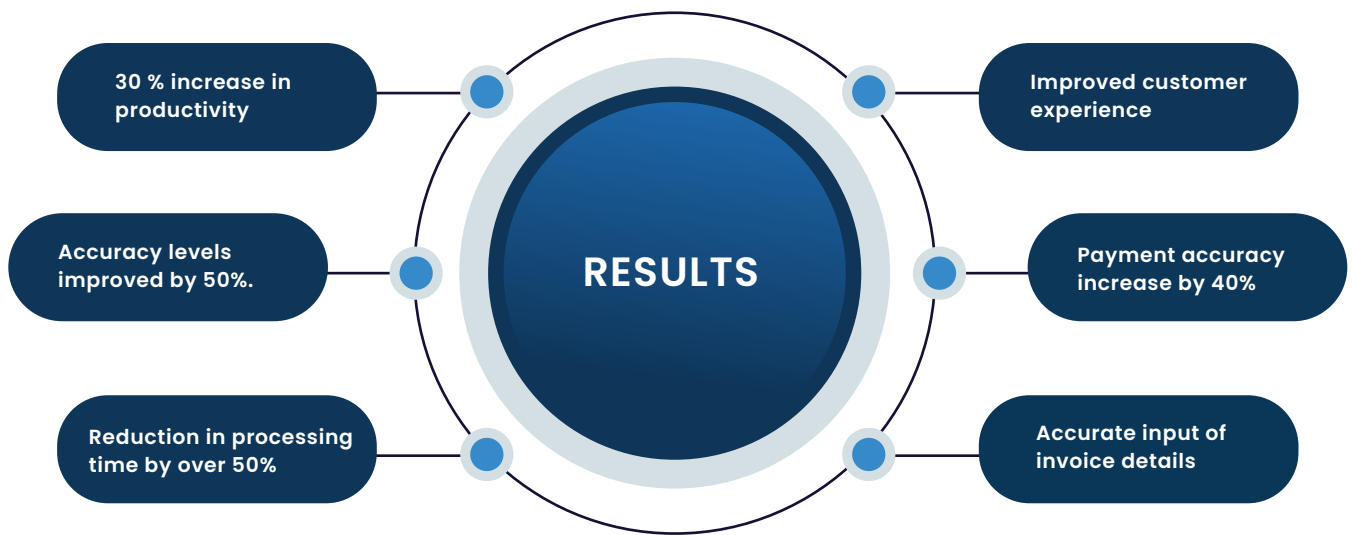
Identification of business needs and formalization of these needs into a project was a joint effort of the client's department heads and our project team. We defined the process structure and implemented it successfully.
